Solano County Water Agency is recruiting interns for the habitat restoration program.

This temporary position requires interns to perform a wide variety of tasks including, but not limited to:

- Carrying up to 25 lbs of equipment or materials
- Designing, constructing, and maintaining irrigation for restoration plots
- Implementing and supervising volunteer planting events
- Operating tractors, forklift, herbicide spray rigs, ATV's, backpack sprayers
- Maintaining, and repairing vehicles and other equipment
- Assisting in collecting, processing, and delivering native plant materials
- Gathering data using GPS units for investigations and monitoring programs

On-the-job training will also be provided to successful interns on the various tools, equipment, and vehicles.

Ideal candidate qualifications:

- Strong interest in habitat restoration, ecology, or related field
- Willingness to quickly learn and identify native riparian plant species
- Must be able to work in California weather conditions
- Must be comfortable working independently as well as collaboratively

Interns may be exposed to loud noise levels, cold and hot temperatures, inclement weather conditions, road hazards, chemicals, mechanical and/or electrical hazards, and hazardous physical substances and fumes.

Driving record from DMV, safety training provided by the Agency, proof of vehicle insurance.
