June 12, 2025, LPCCC Meeting Minutes.

- **1. Approval of the Current Agenda:** The agenda was adopted unanimously. Chair Cole was absent and Vice-chair Reid ran the meeting.
- **2. Approval of Minutes of May 8, 2025 Meeting:** Minutes were adopted unanimously with Thronson abstaining.
- **3. Public Comment:** There were no public comments.

4. Pattern Calendar:

There was a technical issue and a recording was not made for this item, so the minutes for this item are sparse. Phil Stevens, Executive Director of the Putah Creek Council (PCC) gave an overview of PCC programs and activities. The OneCreek Program is a paid eight week program that provides hands-on experience within restoration projects in the Putah-Cache watershed. The Creek Explorers program provides opportunities for Solano and Yolo County PreK – 5th grade students learn more about the Putah Creek bioregion. Other programs provide for community members to clean up the creek and participate in native plant restoration.

5. Homeless in Putah Creek: Part Two, Local Agency Staff Panel

The Committee reviewed notes from a past meeting of the Yolo/Solano Homeless Task Force that was held on Oct 4, 2023. Additionally, data on quantities of trash debris removed by SCWA staff were reviewed (150 cubic yards removed from Winters Putah Creek Nature Park WPCNP in 2023). Community member Don Sanders stated he voluntarily cleans up the WPCNP weekly and sanitation is a main issue. LPCCC members brought up issues with wildfire safety, jurisdiction lines, and coordination between agencies. JP Marie reported on homeless camps in the UCD Putah Creek Riparian Reserve.

John Miller (Chief of Police, City of Winters) stated that there is a no-camping ordinance in the WPCNP that is enforced only on the north side of the Creek due to jurisdiction issues. He estimates that between 5 and 8 people live in the WPCNP regularly. Miller also stated that he has seen rip-rap used in other areas as an effective deterrent. Miller also stated that the Solano County sheriff, responsible for the south side of WPCNP, has only 2 sheriffs for the whole County. Since Putah Creek is the dividing line between Solano and Yolo Counties, there are multi-jurisdictional issues.

The Chief confirmed that homeless camping on private property is much simpler to deal with as it is considered trespassing. The police or sheriff needs permission to enter from the landowner to enforce trespass laws.

Thronson asked what is the scope for the LPCCC? The LPCCC cannot solve homeless issues in all of California. Can the LPCCC focus on the environmental impacts of homeless camps? Huber would like to delineate the environmental issues of most concern on Putah Creek. Hether also had questions about the impact of water quality. Vice-Chair Reid asked Stevenson to summarize water quality and restoration/environmental issues at the next meeting, with focus on the salmon run. Stevenson said he would do so and also summarize recreational user impacts.
