5. **2025 Salmon Run Update**

A group of Water Agency staff gave a presentation on various aspects of the salmon run.

- a) Gravel Scarification and Augmentation - Jay Cuetara
- b) Barriers to Fish Passage (pulse flows, beaver dam and check dam management) – Zach Hyer
- c) Number of adult salmon at UCD counting weir – Max Stevenson
- d) Low Dissolved Oxygen as a barrier to fish passage, 29 salmon died below LRCD Oct 22, 2025 – Max Stevenson
- e) Winters Salmon Festival and Accord 25th Anniversary - Alex Fox and Elise Shtayyeh

6. **Unhoused Issue Draft Letter**

The draft letter was reviewed. Chair Cole provided the original draft and the Planning Subcommittee suggested additions and changes to the letter. Salamunovich suggested adding poaching and dogs to the letter. Hyer stated he saw no evidence of poaching this year. Wimmer approved of the draft with removal of the idea of provided temporary sanitation (portable toilets). Huber suggested sanitation services could remain in the letter as a potential recommendation to be considered. Hasbrook asked about the activities of the Solano County Sheriff. The Sheriff has a homeless specialist sheriff that regularly visits the Creek. Don Sanders voluntarily cleans up the camps weekly, or even more often. Thronson suggested a soft recommendation of increased interagency communication. Heter suggested the main point of the letter was to raise awareness. The Planning

Subcommittee was given direction to finalize the letter, perhaps suggesting restarting unhouse housed forum meetings from 2023. These meetings were previous hosted by the City of Winters. Reay suggested inviting landowners. Thronson wanted to confirm the Putah Creek Council is involved.
